Student's Right to Know Disclosure Completion Rates

The <u>2014 Cohort Completion Rate</u> for first-time students in full-time programs at Fortis Institute - Towson is <u>43.3%</u>. This rate is based on the 312 students who started their program between September 1, 2014 and August 31, 2015. Of the 312 students who started their program, 135 students completed their program of study within 150% of normal completion time. Please refer to the institution's catalog for the normal complete time of each program. The above data excludes 24 students whose last date of attendance was less than 30 days after the first class day of their program that was greater than one academic year in length and students whose last date of attendance was less than 15 days after the first class day of their program that was less than or equal to one academic year in length.

The combined **2014 Cohort Completion Rate** for first-time students in full-time programs at the campuses attached to the Office of Post-Secondary Education Identification (OPEID) number 010319 is **49.1%**. The OPEID number is comprised of Fortis Institute -Towson, Fortis College - Smyrna, Fortis College - Columbus, Fortis College - Cincinnati and Fortis College - Columbia. This rate is based on the 1,133 students who started their program between September 1, 2014 and August 31, 2015. Of the 1,133 students who started their program, 556 students completed their program of study within 150% of normal completion time. Please refer to the institution's catalog for the normal complete time for each program. The above data excludes 83 students whose last date of attendance was less than 30 days after the first class day of their program that was greater than one academic year in length and students whose last date of attendance was less than 15 days after the first class day of their program that was less than or equal to one academic year in length.






